The National Power Grid Company Transelectrica SA informs the shareholders and investors about its signing an addendum amounting to more than 50,000 Euro with SC TELETRANS SA.

Addendum (A): Addendum (A) no. 2 to contract C256/2014;

Parties: CNTEE Transelectrica SA – as purchaser;  
SC TELETRANS SA – as provider;

Contractual object: Maintenance services and operation of the telecommunication, process IT and information technology systems;

Total addendum value: 28,164,402.02 Lei VAT fee;

Term of addendum: 12 months;

Guarantees: Within 10 days from Addendum signature the Provider shall supplement the performance bond quantum up to the equivalent of 1,408,220.10 Lei, representing 5% of the amount by which the Contract value has been supplemented;

Penalties (changed clauses): In case the Provider fails to carry out in due time the obligations assumed under Contract, the Purchaser can require 0.02% penalty per day of delay from the amount of the non-executed order/service/executed with delay;  
The Provider commits to reimburse the complaints and law suits that result from the violation of certain intellectual property rights relating to the provided services, the damages, costs, fees and expenses of any kind;

Mutual liabilities: None;

Terms of payment: In accordance with the initial contract (that has been reported on 01 July 2014 according to article 225 of Law 297/2004).

All the other provisions of Contract C256/2014 which are not changed by Addendum provisions remain valid and apply further.
