Important events to be reported: Settlement Agreement extinguishment of the disputes

The Board of Directors informs the shareholders and investors of the conclusion of the Settlement Agreement whereby the Company agreed, through mutual concessions, to extinguish, finally and irrevocably, the following disputes:

- (a) File No. 23619/3/2009\*\* on the dockets of the Bucharest Court of Appeal, having as its object an action for establishment of the legal compensation for RON 3,927,170.82, where the Company is a plaintiff and Brooklyn Property Management S.R.L., a Romanian company with its headquarters in Bucharest, Str. Tuzla No. 9-27, 2<sup>nd</sup> Floor, Apt. B2, Sector 2, registered with the Register of Commerce under No. J40/11322/2008, holding Unique Code No. RO 24115253 ("Brooklyn") is a defendant, which is in the appeal stage (the third procedural cycle);
- (b) File No. 32874/3/2010 on the dockets of the Bucharest Tribunal, having as its object claims amounting to RON 3,483,959.66 and penalties amounting to RON 5,654,180.32 related to Execution Agreement No. 6 Topaz/18.05.2007, representing payment for the performance of works, where Brooklyn is a plaintiff and Impact is a defendant, in the first stage of jurisdiction, suspended until the judgment of File No. 23619/3/2009\*\*;

(c) File No. 45886/3/2009 on the dockets of the Bucharest Tribunal, having as its object an action for abusive execution of the Bank Letter of Guarantee related to Execution Agreement No. 6 Topaz/18.05.2007 for EUR 317,422.39, where Brooklyn is a plaintiff and Impact is a defendant, in the first stage of jurisdiction, suspended until the judgment of File No. 23619/3/2009\*\*.

In exchange for the mutual concessions agreed, Impact paid the RON equivalent of EUR 880,000 to Brooklyn, today, 27.11.2018.
