NOTE:

We inform the investors that SIF Banat-Crisana's net assets value recorded a decrease of 7.54% compared to the previous month, from RON 2,711,997,890 (31.10.2018) to RON 2,507,628,836 (29.11.2018).

The decline is mainly due to the decrease by RON 249 mn of the stake held in SIF Imobiliare PLC, an issuer listed on the AeRO-BVB market and for which there were no transactions during the last 30 trading days.

Therefore, as at 29.11.2018, the valuation of SIFI titles was calculated in accordance with the provisions of art. 115 par. (2) and par. (1) letter (a) pt. (1) of the ASF Regulation no. 9/2014, at the book value per share, as it results from the last approved financial statements of the issuer.
