Please find attached SIF Moldova Assets and Liabilities Statement on **January 31, 2019**, in compliance with FSA Regulation 9/2014 - Annex 16 - along with a brief analysis of the main variations registered in the value and structure of the assets under management.

The total value of the assets under management was of 1.759 billion lei, down 4.6% from the previous month.

Main developments registered by asset classes:

- listed shares: 72.8 million lei;
- unlisted shares: + 6.4 million lei;
- non-traded fund units: 5.9 million lei;
- monetary instruments: 10.5 million lei.

The price of the quoted shares was negatively influenced by the Government Emergency Ordinance no. 114/2018.

The weight of the main asset classes in the total value of the assets under management as of January 31, 2019: listed shares, including non-UCITS listed shares 71.1%, unlisted shares 12%, non-traded fund units 11.8%, monetary instruments 3.7%.

Compared to the previous month, the SIF2 share price on January 31, 2019 was of 1.1600 lei, down by 4%, while the net asset value per share was of 1.6779 lei, down by 3.6%. The SIF2 price/NAV per share discount is maintained at 31%.
