## **Important events to be reported:**

TTS informs shareholders and investors on the publication of the "TTS February 2024 Trading Bulletin – Liquidity and Market Capitalization".

# February 2024, in brief:

- In February 2024, TTS shares ranked on the 12'th position of the most traded shares listed on the Bucharest Stock Exchange ("Monthly Bulletin. FEBRUARY 2024", with a value of of 21,976,560 lei (4,772,162 USD), representing 2.29% of the total value of transactions registered by the shares included in the Premium Category.
- The median daily volume of TTS shares traded in February 2024 was 26,342 shares (-41.5% Δ Feb-24 / Jan-24, +10.9% Δ Feb-24 / Feb-23), with 17.56% higher than the liquidity threshold required for inclusion in the FTSE Russel Global SmallCap Index, which is equal to 22,408 shares, representing 0.05% of the free float (44,815,680 shares).
- In February 2024, **751,001 TTS shares** were traded ( **-35.2%**  $\Delta$  Feb-24 / Jan-24, **+44.1%**  $\Delta$  Feb-24 / Feb-23), **the daily average** being **35,762 shares** ( **-38.3%**  $\Delta$  Feb-24 / Jan-24, **+10.9%**  $\Delta$  Feb-24 / Feb-23).
- The total traded value was **21,976,560 RON** ( **-33.6%**  $\triangle$  Feb-24 / Jan-24, **+228.2%**  $\triangle$  Feb-24 / Feb-23), **the daily average** being **RON 1,046,503** (**-36.8%**  $\triangle$  Feb-24 / Jan-24, **+212.6%**  $\triangle$  Feb-24 / Feb-23).
