## **DECISIONS OF THE INDEX COMMITTEE IN THE MEETING OF MARCH 9, 2021**

[Bucharest Stock Exchange \(BVB\)](#) informs that on March 9, 2021 the quarterly meeting of the BVB Index Committee ("CI") took place. BVB Index Committee has decided the following:

1. To maintain the composition of BET and BET-TR indices;
2. To maintain the composition of BET-XT and BET-XT-TR indices;
3. To maintain the composition of BET-BK index;
4. To change the composition of BET Plus index, as follows:
  - 4.1. include: TURISM FELIX S.A. (symbol TUFE, ISIN ROTUFEACNOR7);
  - 4.2. exclude: AEROSTAR S.A. (symbol ARS, ISIN ROAEROACNOR5); MECANICA CEAHLAU S.A. (symbol MECF, ISIN ROMECFACNOR0);
5. To maintain the composition of BET-NG and BET-FI indices.
6. The weights of the indices' components, i.e. the free-float factors ( $F_{fi}$ ), the representation factors ( $FR_i$ ), the liquidity factors ( $FL_i$ ) and the price correction factors ( $FC_i$ ), will be determined based on the number of shares and closing prices registered at the end of the trading session of **March 12, 2021**.

The new structures of BVB indices will be announced at the end of **March 12, 2021** and will become effective starting with **March 22, 2021**.
