## **CONNECTIONS CONSULT SHARES WILL START TRADING ON THE AeRO MARKET ON SEPTEMBER 22**

**Bucharest Stock Exchange (BVB)** informs that on Wednesday, September 22<sup>nd</sup>, the shares of **Connections Consult**, a Romanian company founded in 2005 and specialized in providing software and IT services, will start trading on the AeRO market under the ticker **CC**. The company has regional presence, with offices in Romania, Bulgaria, and Serbia.

Connections Consult listing comes after a private placement held in July 2021. The company issued 144,928 new shares, with RON 0,10/share nominal value. The shares were sold during the private placement for RON 68 per share, thus the future-AeRO market issuer managed to attract from the capital market investors funds worth RON 10mn. A number of 184 investors subscribed during the private placement, out of which 45 qualified investors (including professionals) and 139 retail investors. Among the retail investors, nine are Romanian legal entities, two are foreign individuals and 128 are Romanian individuals. The value of the anticipated capitalization amounts to RON 74.5mn. The private placement and listing were made with the support of **TradeVille**.

Connections Consult team will ring BVB's bell for the company's listing on Wednesday, September 22<sup>nd</sup>, at 10 AM. The Opening Bell ceremony will be broadcasted LIVE on BVB's social media channels **Facebook**, **YouTube** and **LinkedIn**.
