

## BVB SPONSORSHIP AND DONATION POLICY Version 2. December 20, 2017

### 1. Introduction

Among the leverages to achieve the mission of the Bucharest Stock Exchange, the Corporate Social Responsibility (CSR) projects are of long term and high importance. We are involved in the communities where we operate or target to operate or develop business, and we are generally committed to supporting causes where we can leverage our unique skills and assets as a capital market leading institution, in order to make a real difference. The selected CSR projects are the ones which will benefit of BVB sponsorships and donations. BVB will generally give priority to projects that supports the global nature of our business and promotes our vision of creating opportunities in capital markets area.

### 2. General overview of CSR directions

In the area of Corporate Social Responsibility, BVB supports projects in 1/education, especially focused on financial literacy, and 2/environment protection.

#### Education

In the Romanian society, the education level in economic-financial area, especially capital markets, it is at very low level. To raise the level of education of young generation in this field becomes an obligation of the whole society, not only of the persons or institutions directly responsible for education.

All decisions on donations and sponsorships will be made taking into consideration BVB company's reputation and the values as expressed in the BVB Code of Ethics and the Regulation on the Organization and Functioning of BVB, thus all projects non compliant with the above mentioned will be rejected.

### Donation

Is a contribution in cash, goods or services to support an activity, a project, an organization or a person, under the CSR Directions mentioned above, for which no direct benefit is expected in return.
