Bursa de Valori Bucuresti, hereby informs the public that, in the case no. 979/3/2012 pending before the High Court of Cassation and Justice – Second Civil Chamber, **in the higher appeal stage**, on December 6, 2016 the court **rejected** the higher appeals of Appellant (Plaintiff) - Muntenia Imobiliare Development SRL, Appellant (Defendant) - Banca Comerciala Romana S.A. Bucuresti and Appellant (Defendant) - Erste Group Bank A.G. against the civil decision no. 1878/November 12, 2015 of the Bucharest Court of Appeal - Civil Section. **The decision is irrevocable.**

Please be informed that:

- **In the appeal stage**, by decision no. 1878/November 12,2015, the Bucharest Court of Appeal maintained the dispositions of the resolution of the Bucharest Tribunal related to Bursa de Valori Bucuresti S.A. and ordered to Muntenia Imobiliare Development SRL (Appellant) to pay to Bursa de Valori Bucuresti S.A. the amount of Lei 10,176 lei representing costs incurred

during the appeal stage; and

- **In the merits stage**, by Resolution no. 1442 /March 23, 2014, Bucharest Tribunal rejected the application filed by Muntenia Imobiliare Development SRL and ordered Muntenia Imobiliare Development SRL to pay to Bursa de Valori Bucuresti S.A. court costs in the amount of 19,383.69 lei (representing attorney fees).

There are no other events to be reported.
