1. General information about main activities

Oil Terminal S.A. Constanta is a stock company residing in Romania. The company has the social headquarter in Constanta, no.2, Caraiman street.

The company was founded according to Law 15/1990 and Romanian Government' decision no.1200/12.11.1990, S.C.Oil Terminal S.A., being a stock company and was registered at Commerce Registrar Office of Constanta Court under no. J13/512/01.02.1991, having fiscal register code RO 2410163.

OIL TERMINAL is the largest terminal for import/export of crude oil, petroleum and petrochemical products at a national level.

According to the company' statute, the object of activity includes services supplies regarding crude oil, petroleum and liquid chemical products storage, receiving, loading, discharging and conditioning from import/export and transit.

Oil Terminal SA Constanta has a storage capacity of about 1.5 million metric tons and is the largest operator by sea in Constanta port, specialized in crude oil, petroleum, liquid petrochemical and other finite products and other liquid raw liquids for import, export and transit, representing a strategical location in the Black Sea area.

The oil terminal in Constanta is one of the largest of this kind in south-eastern Europe, located in the maritime transport crossroads among Asia, Central and Western Europe and Middle East.

Old of 120 years in this field of activity, the company provides crude oil, petroleum, petrochemical and liquid chemical products' import, export and other services supplies.

OIL TERMINAL S.A has three storage farms (North, South, Port). Each storage farm, according to its characteristics, being provided with:

- Shoretanks with capacities between 1,000 cm and 50,000 cm, of metallic construction, cylindrical, vertically located –above ground, safety protection belts, fixed or floating roof, with the stored product quantity remotely measured and with fire fighting system;
- Facilities for petroleum, petrochemical and liquid chemical products loading-discharging consisting of rail platforms with a total length of abt. 30 kms with a cummulated capacity of abt. 20,000 tons/24 hours;
- Facilities for gas oil loading into railcars provided with volumetric flowmeters;
- Transport pipelines with diameters between 100 and 1000 mm, for withdrawals inside the storage farms, the connection among them and the jetties where vessels are operated;
- Pump houses achieving flows between 100 cm /h and 2,500 cm/h;
- Facilities for firefighting consisting of pipelines reaching each shoretank, pump houses, fire fighting stuff specific for each product, firemen equipped by fire fighting cars;
- Boiler for technological steam supply;
- Laboratories RENAR authorized, provided with apparata to determine specific physical, chemical tests;
- Facilities to catch and clean waste waters;
- Equipments for railcars' manoeuvre in discharging platforms by engines and own staff, AFER certified and authorized.

Oil Terminal is located in mol 4 Constanta port area, jetties 69 - 79. This operates 7 operational jetties from which 6 have depths of 12.80 m and a length of 325 m - jetties 69-76, jetty 79 has the depth of 17.50 m and length of 393 m, allowing operation of vessels with a capacity up to 150,000 dwt.

Jetties are provided with coupling facilities at vessels for loading, discharging, hydraulically operated, with diameters of 12" WOODFIELD type in jetties 70-76 and with diameter of 16" FLEXIDER type in jetty 79.

Each jetty is provided with fire fighting water and foam facilities. Jetties 69-73 are provided with water/foam cannons. Jetties 75,76,79 have firefighting water/foam located in cannons at a height of 16 m remote control. There is also facility for water wall formation between vessel and Oil Terminal facilities.

OIL TERMINAL SA is interconnected with Romanian reffineries by transport company CONPET SA Ploiesti for crude oil' transport from terminal to reffineries, by underground pipelines being part of national transport network.

Terminal is also connected to the national rail system, road system and Danube-Black Sea canal. The main internal market competitors are:

- Midia port terminal operated by Rompetrol Rafinare SA Constanta;
- Terminal Unicom-Oil Terminal Galati;
- Frial SA Constanta and Minmetal SA Constanta
- Terminal of Omisalj port in Croatia, which undertook the total crude oil transit to Serbia;
- Reni terminal.

The company has certificate for quality management received from Bureau Veritas Certification Romania, available until 13 May 2021.

The main services supplied by the company are:

- receiving, storage, conditioning and dispatch of rude oil, fuel oil, petroleum, petrochemical and liquid chemical products for import, export and transit;
- tests and technical analyses for the handled products in own laboratories;
- tests and technical analyses for the third parties in own laboratories;
- repairs and maintenance works for its own facilities and equipments;
- its own facilities' hiring;
- wholesale of residues and wastes.

The turnover achieved on 30.09.2019 is 125,841,994 lei. Comparing to the same period of the previous year, an increase in the absolute size of 21,327,215 lei was recorded.

2. Significant accountancy policies

The accountant policies applied to these simplified interim financial situations are the same as those applied in the company' financial situations on the date and for the financial year completed on 31st December 2018, excepting the adoption of new standards in force since 1 January 2019. The company did not adopt in advance other issued standards, interpretations or amendments, not being still in force. The company adopted IFRS 16 Leasing contracts for the first time since 01.01.2019.

IFRS 16 Leasing contracts replaces IAS 17 and settles new requirements to account leasing contracts. In the holder's accountancy, according to IFRS 16, the classifications in operational or financial leasing of IAS 17 are elliminated, there is a single model to record the leasing contracts. According to IFRS 16, the holder is obliged to record the right to use the asssets and debts related to leasing contracts for IFRS 16 target, for the revenues and expenses, it will recognize the amortization of the asets usage right, apart from the interests related to leasing debts.

The company applied IFRS 16 since 1 January 2019, using for each trade the altered retrospective method, without re treating the comparative values for the previous presented period.

On 1 January 2019, the company recognized assets as rights to use support assets in the account "Assets related to the rights to use assets taken in leasing" and leasing debts in account "Other loans and assimilated debts", arisen from the previous operational leasing contracts.

The rights to use support-assets according to which leasing contracts are monthly lineary amortized during leasing contracts period.

The interests expenses are recorded in the account profit loss during the leasing contract period, being calculated for the debt outstanding balance regarding the leasing for each period. In the holder's accountancy, alterations comparing to IAS 17 are minor.

The interest rate was settled by the company depending upon it would cost the entity if it borrowed on a market to use the support.

In the financial position report, the right to use the assets is presented in the intangible assets and the leasing debts are presented in other loans and assimilated debts, distributed on debts on long term and current debts.

2.1 Conformity Statement

The simplified interim financial situations were issued according to Public Finances Ministry' Order no.2844/2016 for approval of Accountancy regulations complying with International Standards of Financial Report ("IFRS").

These financial reports were issued according to IAS 34 – Interim financial report. These don't include all necessary information for a full financial situations set according to International Standards of Financial Report (IFRS).

Nevertheless, some Explanatory Notes are included in order to explain the outstanding events and trades to understand the alterations occurred in the company" financial position and performance since the latest financial situations, on the date and for the financial year completed on 31st December 2018.

The simplified interim financial situations on 30 September 2019 were revised by an independent auditor.

These simplified interim financial situations on 30 September 2019 were authorized to be issued and signed by the company' management on 8 November 2019.

2.2. Functional and presentation currency

These reports are presented in lei, this being the company' functional currency.

The whole financial information is in lei, rounded to integer if not mentioned otherwise.

2.3 Use of estimations and professional reasonings

The preparation of the financial reports according to IFRS supposes the management' use of some estimations, judgements and suppositions affecting the accounting policies application and the assets, debts, revenues and expenses' reported value. The estimations and suppositions associated to these estimations are based on the hystorical experience and on other reasonable factors in the context of these estimations. The results of these estimations are the base of the judgements regarding the assets and debts' accountant values not being got from other information sources. The current results can be different from the estimations values.

The outstanding reasonings used by the management to apply the company' accounting policies and the main uncertainties sources regarding the estimations were the same as those applied the annual financial situations on the date and for the financial year completed on 31st December 2018.

2.4 Transactions in foreign currency

Transactions in foreign currency are changed into the company' functional currency using the exchange rate of the trade date.

By Civil sentence no. 16622/24.10.2012, Constanta Court admits the summons submitted by the claimant OIL TERMINAL SA, in contradictory with the defendant SC Byotech Prod General SRL. It obliges the defendant to pay the amount of 164,066 lei, to the complainant, representing the countervalue of VATfor the excise of 863,504 lei and the amount of 87,119 lei, representing delay penalties. It obliges the defendant to apy to the claimant court expenses in an amount of 8,255.70 lei.

Request of enforcement was submitted. The bailiff put garnishment to all the debtor' accounts. Until the present date, the debt hasn't been recovered due to funds' lack. For this file, a provision of 246,970 lei was constituted.

Action in claims submitted by SNTFC – CFR, RTF Calatori lasi and SNTF CFR Marfa SA SUC. lasi to lasi Court of Justice on 27.22.1011, by which the complainants ask the court t ogive a decision, by which the defendants SC Oscar Downstream SRLand Oil Terminal SA to be obliged to pay the amount of 44,400.98 lei, representing the countervalue of 12,075 kgs gas oil. The request is the object of file no. 2884/245/2011. By the conclusion of 21.06.2011, the court suspended the present file' solution until the criminal file' solution.

The litigation is pending on again and, by Civil sentence no.14336/21.12.2018, the court rejected as groundless, the defendants OIL TERMINAL and OSCAR DOWNSTREAM SRL' passive procesual quality lack, invoked by contestation, admitted the summons submitted by SNTFC-CFR, RTF Calatori Iasi incontradictory with the defendant SNTF CFR Marfa SA SUC. Iasi, obliged the defendant SNTF CFR Marfa SA SUC Iasi to pay the claimant the amount of 44,400,98 lei, rejected the summons submitted by the claimant SNTFC – CFR, RTF Calatori Iasi in contradictory with the defendants OIL TERMINAL and SC OSCAR DOWNSTREAM SRL, as groundless, rejected the summons for guarantee of OIL TERMINAL SA, submitted by the defendant SC OSCAR DOWNSTREAM SRL, as being without object and obliged the defendant SNTF CFR Marfa SA SUC. Iasi to pay the claimant the amount of 2,387 lei, representing court expenses – stamp tax.

By decision no.1617/13.10.2016, Bucharest Court of appeal rejected the appeals submitted by SC Autocora SRL and SC Interagro SA, as groundless.

The decision is final and has not been communicated yet. By Decision no. 204/02.02.2017, the court rejected the appeal as groundless.

File no.36095/3/2015, pending on Bucharest Court of Justice, the term of 05.10.2018, the court gave the following inetrim solution: it admits the requests of debtor SC INTERAGRO SA, by special administrator Cadar Marcel and judiciary administratyor CITR FILIALA Ilfov SPRL. It obliges the defendant to pay the claimant the amount of 601,336.89 lei, the equivalent of 154190.20 USD, representing cutter stock oil pruduct storage invoices and delay penalties related to debt. It obliges the defendant to pay the claimant the amount of 20,998.84 lei, representing court expenses. The sentence was appealed by Master Chem Oil DMCC, the file has the first term in Constanta Court of Appeal on 06.11.2019.

For this client, a regulation for the receivable' impairment in an amount of 601,337 lei was constituted.

For this client, a regulation for the receivable' impairment in an amount of 879,355 lei was constituted.

The structure of the engaged capital is made of own capitals including: social capital, othe own capital elements, result reported representing surplus achieved from reevaluation reserves, reported result from IAS application for the first time, less IAS 29, legal reserves, reserves from reevaluation, other reserves and year result, according to presentation in Report of own capitals and debts alteration including loans on long term presented in note 28.

Capital risk management is part of the company business management and is reported to the permanent review of the company' indebtedness degree. The indebtedness degree calculated as report between debts on short term/own capitals was 0.054 on 30.09.2019 and 0.041 on 30.09.2018.

The company management regularly reviews the capital structure and reports of risks.

The review covers the capital cost and the risks associated with each capital category included.

Credit risk

Credit risk is the risk of financial loss for the company arising when a client or a business partner doesn't succeeed to achieve contractual obligations. The company is exposed mainly to credit risk arisen from the services supplied to the clients. Annualy, the contracts content regarding the services supplies for all liquid

petroleum products are approved by National Agency of mineral Resources' order. In these contracts, the commercial terms to fulfill the service supplied by the company to clients are presented:

- payment of services supplied in maximum 30 days;
- accessories calculation (penalties and delay interests) for the payment uneffectment in contractual terms by clients;
- in certain situations, well contractually stated, the revenues are cashed in advance;
- if the invoices are not paid in the term stipulated in contract, the company has the right to retain the transited cargo, until the amounts due by the clients payment.

Foreign currency risk

Currency risk occurs when the company concludes transactions expressed in another currency than those functional ones.

It depends on decision factors outside the company, namely Romanian National Bank policy regarding the currency evolution in a certain period of time.

Liquidity risk

The risk of liquidity arises from the management of working capital and the financing expenses and main amount reimbursement for the company' credit instruments.

Oil Terminal' policy is to ensure that it always disposes enough cash to allow the financial obligations complying to third parties (materials, services suppliers, employees, banks, state financial institution s, etc) when these obligations are due for payment.

To achieve this objective, the company took the following measures:

- monitoring of cashings in contractual term;
- contraction of a credit line type work capital and its use only in situations when the current cash balance is not enough for the due payments effectment;
- keeping of a cash balance to satisfy the payments necessities;
- issuing of a cash flow, weekly.

By applying the above - mentioned measures, the company has enough liquid resources to achieve its obligations in all reasonable predicted situations.

The liquidity indicators provides the guarantee to cover the current debts from current assets.

The current liquidity represents the ratio between the current assets and the current debts, recording on 30.09. 2019 the value of 1.64 comparing to 1,24 on 30.09.2018.

The immediate liquidity (acid test) represents a ratio between the diminished current assets by stocks and the current debts, this indicator' value being 1.58 on 30.09.2019 comparing to 1,19 on 30.09 2018.

- 97 risks of level "tolerable" percentage 89.81%;
- 10 risks of level "high tolerance" percentage 9.26%;
- 1 risk of level 'low tolerance" percentage 0.93%;
- **0** risks of level"intolerable" percentage 0%.

From the critical analysis of Risks registrar, updated and centralized in the company on 30.06.2019, revised on thereference date 30.06.2019, the evolution of risks to be managed on the reference date 30.06.2019 had the following trend:

- increase of risks total number retained to be managed in the company
- increase of risks classified as "tolerable", namely now, namely from 94 risks on 10.06.2019 to 97 risks on 30.06.2019
- constant maintenance of the number of risks classifed as "high tolerance" (10 risks)
- constant maintenance of the number of risks classified as "low tolerance" (1 risk)
- there were no risks identified as being classified as "intolerable"

Costs calculation is the basis of services supplies tariffs settlement in the company, representing the main factor for the company' internal reserves prospection, identification and mobilization.

By the costs' periodic survey per product conventional ton, a balance is provided between the average cost per product ton and the average revenue achieved in the same measure unit, so that the service supplied are efficient and bring a value surplus.

Risk of interest rate

Operational cash flows are afected by interests rate variations, mainly due to loans contracted on long term. The company has significant long term loans, with variable interest, exposing it to a cash flow risk. In view to manage the interest rate risk, the company dets are permanently monitored for the due dates, by clients cashing policy providing the resources necessary for debts payment.

3. COMPANY' ACTIVITY ANALYSIS

3.1 Analysis of operational activity

3.1.1 Regulation framework

Societatea Oil Terminal' main object of activity complies with CAEN code 5224 Handlings – services supplies regarding receiving, loading, discharging of crude oil, petroleum, petrochemical, chemical products and other finite products or raw liquid materials for import, export and transit.

The company' base operational activity is regulated, mainly, by provisions of Oil law no.238/2004 and of Lease oil agreement agreement concluded with National Agency for Mineral Resources

3.1.2 Main activity

Elements with impact on the revenues from main activity

Tariffs

For the services supplied to clients, the company applies regulated tariffs (approved by ANRM) and by non regulated tariffs (approved according to provisions of the company' Constitutive Act).

Regulated tariffs applied by the company in period 01.01. – 30.09.2019 were approved by ANRM Order no.156/03.08.2018, in force on 13.08.2018, publishing date in Official Gazette, Part I no.703/13.08.2018. Other tariffs applied by the company, namely, services of fuel oil, chemical products, hires, different laboratory analyses are non regulated tariffs approved according to provisions of art.18, paragraph (4.1) of Societatea' Constitutive Act.

Correction of the Budget of revenues and expenses for 2019

By AGOA' Decision no.9/13.05.2019, the Budget of revenues and expenses for 2019 was approved. After having consulted the clients regarding the prognosis for the period August-December 2019, an additional increase of 22% compaing to the initially approved quantity for the same period of the year, namely by 526 thousand tons arises

Therefore, until the end of 2019, it estimates an increase of the initially approved physical program by 13% (namely by 751 thousand tons) from 5,593 thousand tons to 6,344 thousand tons, generating an addition of revenues from the supplied services in a total amunt of 17,849 thousand lei and determined the necessity to correct the Budget of revenues and expenses for 2019

The level of the corrected Budget of revenues and expenses' main indicators for 2019 is as follows:

- Total revenues increase by 11.9% on the increase of revenues from the supplied services (by 17.8 mill. Lei)
- Total expenses increase by 10.8% (16.2 mill. Lei)
- Gross profit increases by 90.5% from 2.1 mill. Lei to 4 mill. Lei

By the Board of Directors' Decision no. 98/06.09.2019, the corrected draft of Budget of revenues and expenses for 2019, together with its substantiation annexes and the estimates for the next two years, namely, 2020-2021.

According to provisions of art. 4 paragraph (1) letter d) of GD no.26/2013 together with art. 12 paragraph (3) letter f) of the Company' Constitutive Act, the corrected Budget of revenues and expenses for 2019 and the estimates for the next two years, namely, 2020-2021, together with the substantiation annexes, was approved by AGOA' Decision no.18 of 29.10.2019, complying with the mentionings of art.10 paragraph (4) of GD no.26/2013 providing that the budgetary correction can be made until 31 October of the current year.

3.1.3 Other activities

Other activities, with a percentage of 2.1% in the company' turnover are represented by the fixed assets' hire, rail cars manoeuvre, wastes sale, etc.

3.1.4 Evaluation of operational activity

On 30.09.2019 total revenues increased by 20.5% and turnover by 20.4% comparing to the same period of 2018.

3.1.5 Acquisitions

Acquisitions activity in Oil Terminal runs according to Intern Acquisitions Regulation approved by Decision no.95/11.09.2017 of the Board of Directors. The operational procedure regarding the Acquisitions annual program issue and updating, code PO-09.01 and syste procedure Acquistion Management, code PS-08-08.

The company purchases investments works, repairs, maintenance services, independent equipments, materials, protection services, greenings, auditor, evaluations, etc.

As a service supplier, the company Oil Terminal does not record raw materials stocks, the technical material supply activity is achieved, mainly, from local sources, targeting the materils provide for the activity of repairs, maintenance, work safety, administrative, equipment, fuel for its own cars and railcars run.

By address no. 4820/21.07.2016 ANAP communicated that, Oil Terminal has no quality as contractant authority/entity according to Laws 98-100/2016 regarding public acquisitions and has no obligation to apply them.

3.1.6 The company' fusions and re organizations, acquisitions and estrangements of assets on 30.09.2019

In the period 01.01. - 30.09.2019, in the company, no fusions, reorganizations, acquisitions and estrangements of assets occured.

The company has no branches opened in the country or abroad.

3.2 Capital expenses

Investments activity in the company Oil Terminal SA is in two main directions:

- 1. Investments objectives for the company' own patrimony
- 2. Investments objectives related to public domain, according to Minimum program regarding oil terminal' rehabilitation and updating, annex of Lease Oil Agreement concluded with National Agency for Mineral Resources.

For 2019 investments expenses are in an amount of 30,516 thousand lei constituted at the investments financing source level, from which credits reimbursements for investments in an amount of 2,390 thousand lei, and investments expenses in an amount of 28,126 thousand lei.

On 30.09.2019 the recorded investments level was in a total amount of 14,016 thousand lei, being by 4.2% (568 thousand lei) more than the scheduled one (13,448 thousand lei) and by 10.6% more than the same period of the previous year.

On 30.09.2019, the balance regarding the **financial assets** (639,621 lei) increased by 20.4% comparing to 31.12.2018 (by 108,217 lei more) mainly due to a guarantee constitution in favour of Compania Nationala Administratia Porturilor Maritime (637,246 lei on 30.09.2019 comparing to 528,727 lei on 31.12.2018).

Current assets

On 30.09.2019, total current assets recorded an increase of 41.6% comparing to 31.12.2018, determined mainly by the cash flow and the cash flows equivalents increase on 30.09. 2019 comparing to the balance on 31.12.2018.

Debts on long term

. On 30.09.2019, the current debts recorded an increase of 12.7% (8.8 mil. lei) comparing to 31.12.2018 (69.27 mill. lei), further the usage of investments credit contracted in 2018 with BCR in order to achieve the planned investments objectives and to record the debts arisen from the leasing contracts (debt more than 3,104,420 lei per year). The company is an user according to five leasing contracts.

Current debts

On 30.09.2019, the current debts recorded an increase of 18.7% (8.8 mil. lei) comparing to 31.12.2018, mainly due to te recording of the debts arisen from leasing contracts (current debt 1,738,213 lei) and due to loans on long term.

We mention that, on 30.09.2019 the company does not record debts to the state budget, social insurances budget, local budget, banks, investments suppliers, services supplies and goods deliveries and employees.

Own capitals

On 30.09.2019 own capitals increased by 1.8% (7.95 million lei), comparing to 31.12.2018, mainly due to the net profit record in an amount of 8 million lei.

Provisions

The provisions' balance for the litigations recordede by the company on 30.09.2019, in an amount of 2,710,523 lei decreases by 21.1% (722,956 lei) comparing to 31.12.2018.

Total expenses record a saving of 4.2% (5,115 thousand lei) comparing to the approved level by the Budget of revenues (116,716 thousand lei achieved comparing to 121,831 approved).

The operation expenses achieved in period January – September 2019 are in an amount of 114.8 mill. lei, being diminished by 0.4% comparing to the budgeted level, but in increase by 14.1% comparing to the same period of previous year, from 100.6 mill.lei to 114.8 mill. lei. We mention that, in 2019, the company corrected the initially approved Budget of revenues and expenses, diminished the total expenses by 11.1% from 157.3 mill. lei from 139.8 mill. lei correlated with the total revenues diminishing by 13.5%.

Financial expenses achieved are in an amount of 1,934 thousand lei, less by 15.7% comparing to the budgeted level, but increasing by 40.9% comparing to the level on 30.09.2018 due to the investments credit on long term contracted in 2018.

3.4.1 Uncertainties elements that might affect the company' liquidity Credit risk

Credit risk is the risk of financial loss for the company arising when a client or a business partner doesn't succeed to achieve contractual obligations. Societatea is exposed mainly to credit risk arisen from the services supplied to the outstanding receivables.

On 30.09.2019, according to financial results recorded, there is no credit risk.

Liquidity risk

The risk of liquidity arises from the management of working capital and the financing expenses and main amount reimbursement for the company' credit instruments.

The current liquidity recorded on 30.09.2019, the value of 1.60 comparing to 1.24 on 30.09.2018, due to revenues from operation increase by 20.5%.

The immediate liquidity (acid test) on 30.09.2019 is 1.58 comparing to 1.19 on 30.09.2018.

On 30.09.2019, the company records total debts in a value of 102,733,788 lei.

I. File no.1517/118/2012, pending on Constanta Court of Justice, creditor Oil Terminal SA and debtor SC Byotech Prod General, action in claims, by which the defendant is obliged to pay the total amount of 251,185 lei

By Civil sentence no. 16622/24.10.2012, Constanta Court admits the summons submitted by the claimant OIL TERMINAL SA, in contradictory with the defendant SC Byotech Prod General SRL. It obliges the defendant to pay the amount of 164,066 lei, to the complainant, representing the countervalue of VATfor the excise of 863,504 lei and the amount of 87,119 lei, representing delay penalties. It obliges the defendant to apy to the claimant court expenses in an amount of 8,255.70 lei.

Request of enforcement was submitted. The bailiff put garnishment to all the debtor' accounts. Until the present date, the debt hasn't been recovered due to funds' lack. For this file, a provision of 246,970 lei was constituted.

II. File no.11403/212/2011 pending on Constanta Court, by which the claimants lasar Ana, lasar Tair, lasar Doina, lasar Sevinci, lasar Esan, lasar Ghiulgean, lasar Ssbria request the claimants Oil Terminal SA, Oil Prod SRL, Eco Petroleum SA to pay the materials gamages in an amount of 30,000 lei and moral damages in an amount of 60,000 lei.

With appeal in the term provided by art. 244 index 1 paragraph 2 Code of civil procedure. For this file, a provision of 90,000 lei was constituted.

III File 2884/245/2011 pending on lasi Court of Justice, in contradictory with the complainant SNTFC – CFR and the defendants Oil Terminal, Oscar Downstream SRL and CFR Marfa.

Action in claims submitted by SNTFC – CFR, RTF Calatori lasi and SNTF CFR Marfa SA SUC. lasi to lasi Court of Justice on 27.22.1011, by which the complainants ask the court t ogive a decision, by which the defendants SC Oscar Downstream SRLand Oil Terminal SA to be obliged to pay the amount of 44,400.98 lei, representing the countervalue of 12,075 kgs gas oil. The request is the object of file no. 2884/245/2011. By the conclusion of 21.06.2011, the court suspended the present file' solution until the criminal file' solution.

The litigation is pending on again and, by Civil sentence no.14336/21.12.2018, the court rejected as groundless, the defendants OIL TERMINAL and OSCAR DOWNSTREAM SRL' passive procesual quality lack, invoked by contestation, admitted the summons submitted by SNTFC-CFR, RTF Calatori Iasi incontradictory with the defendant SNTF CFR Marfa SA SUC. Iasi, obliged the defendant SNTF CFR Marfa SA SUC Iasi to pay the claimant the amount of 44,400,98 lei, rejected the summons submitted by the claimant SNTFC – CFR, RTF Calatori Iasi in contradictory with the defendants OIL TERMINAL and SC OSCAR DOWNSTREAM SRL, as groundless, rejected the summons for guarantee of OIL TERMINAL SA, submitted by the defendant SC OSCAR DOWNSTREAM SRL, as being without object and obliged the defendant SNTF CFR Marfa SA SUC. Iasi to pay the claimant the amount of 2,387 lei, representing court expenses – stamp tax.

The decision can be appealed in 15 days since communication, until the present date, the civil sentence has not been communicated yet.

For this file, a provision of 44,401 lei was constituted.

IV. File 4010/87/2015, pending Teleorman court, complainant Oil Terminal SA and debtor Interagro SRL Oil Terminal SA submitted an recording request to statement of affairs for the amount of 1,557,336.05 lei. By decision no.317/16.06.2016, court gave the following solution:

- "it partly admits the call for abstention and replacement of legal administrator, submitted by ZRP Insolvency SPRL
- It orders the interim legal administrator replacement represented by legal administrators holding made of CITR Bucharest branch and ZRP Insolvency SPRL by the interim legal administrator CITR Bucharest branch SPRL.

The decision is final and appealed in 7 days since communication.

By decision no.1617/13.10.2016, Bucharest Court of appeal rejected the appeals submitted by SC Autocora SRL and SC Interagro SA, as groundless.

The decision is final and has not been communicated yet. By Decision no. 204/02.02.2017, the court rejected the appeal as groundless.

File no.36095/3/2015, pending on Bucharest Court of Justice, the term of 05.10.2018, the court gave the following inetrim solution: it admits the requests of debtor SC INTERAGRO SA, by special administrator Cadar Marcel and judiciary administratyor CITR FILIALA Ilfov SPRL. According to art.132 paragraph 2 of Law no.85/2014, it orders the reorganization plan deposit extension by 30 days, the next term is for 20.01.2020.

The decision is final and appealed in 7 days since communication

For this file, a regulation for the debt depreaciation in an amount of 1,557,336 lei was constituted.

V. File no.2380/118/2013 and File no.2380/118/2013/a7 pending Constanta court., complainant Oil Terminal SA and debtor Oil Prod SRL. Oil Terminal SA initially submitted the recording request to Firstly a request to record to the statement of affairs with the amount of 242,498.99 lei was submitted. On term 02.06.2014, it ordered the bankruptcy, information address of 04.06.2014.

Further, on term 19.08.2014- court remaining in pronouncing on the legal administrator' request for the company' bankruptcy. The company deposits contestation for recording to the statement of affairs on 04.05.2015.

It settles term for 15.06.2015, when the parties are cited with a copy of the present decision, the court discussing the administration of evidence with the legal accountant expertise to settle: 1. the debts value of creditor Oil Terminal SA arisen after the insolvency procedure opening and after the debtor' bankruptcy, arisen from hire contracts concluded with the debtor; 2. the value of payments effected by debtor Oil Terminal SA to the creditor further the insolvency procedure opening and further the debtor' bankruptcy; 3. value of devt owned by the creditor Oil Terminal SA, arisen after the insolvency procedure opening until the bankruptcy, by deducting the payments effected by the debtor after the insolvency procedure opening i two alternatives:1. by deducting the payments effected by debtor, both from the debts value, arisen before the insolvency procedure opening - recorded in the final table of debtor' obligations and from the value of debts arisen after the insolvency procedure opening until the debtor' bankruptcy; 2. by deducting the payments effected by debtor only from the debts value arisen after the insolvency procedure opening until the debtor' bankruptcy".

The civil sentence has not been communicated yet.

RO0070413DD02 of 22.10.2015, until the first instance' decision regarding the cancellation of the above-mentioned decision. The first term was on 08.03.2018.

By Decision no.419/15.03.2018 given by Constanta Court of Justice ordered the suspension of Decision no.2/21.12.2017 issued by the National Agency of Fiscal Administration - Galati General Regional Direction of Public Finances – Commission for Authorization of Excisable Products Operators, until the first instance decision.

The National Agency of Fiscal Administration appealed on 26.04.2018. By Decision no. 854/20.06.2018 Constanta Court of Appeal rejected the appeal as groundless. The civil sentence has been communicated on 09.07.2018.

For this file a provision of 1,050 lei was constituted.

VII. File no. 4456/118/2018 pending on Constanta Court of Justice having as parties Oil Terminal SA in contradictory with ANAF-Galati Financial General Regional Direction – Commission for Excisable Products Operators Authorization.

On 24.07.2018, Oil Terminal SA submitted an administrative appeal to Constanta Court of Justice, by which it requested the cancleation of Decision no.2/21.12.2017 namely of Decision no. 2/16.02.2018, by which ANAF - Galati Financial General Regional Direction – Commission for Excisable Products Operators

Authorization.ordered the recalling of Fiscal warehouse authorization issued on 22.10.2015. The request is the object of file no. 4456/118/2018 pending on Constanta Court of Justice.

Constanta Court of Justice settled the first term in file no. 4456/118/2018 for 26.11.2019.

For this file, a provision of 15,050 lei was constituted.

VIII. File 1571/93/2018 pending on Ilfov Court of Justice, creditor Oil Terminal SA and debtor – Rottco Consult SRL. Oil Terminal SA submitted a request for joining the debtors claim registrar for the amount of 2,344.04 lei, on 31.07.2018. By decision of 21.06.2018, the court admitted the debtor's request and opened an insolvency general procedure. On term of 03.10.2018, the court ordered the debtor' goods evaluation. The next term is settled for 26.11.2019.

For this file, a regulation for the receivable impairment in an amount of 4,730 lei was constituted.

IX. File 2142/118/2018, pending on Constanta Court of Justice, complainat Oil Terminal SA and debtor – Master Chem Oil DMCC.

Action in claims submitted on 04.04.2018, by which Oil Terminal asks for the payment of cutter stock storage in an amount of 219,977.21 lei (October 2017-February 2018)

Further, written notes were submitted regarding increase of claims for the amount of 601,336.89 lei (145,025.97 USD).

The next term is on 14.02.2019, the decision is pending on.

The decision was postponed for 28.02.2019. On term of 28.02.2019, the court postpones the decision until 14.03.2019.

By Civil sentence no. 563/28.03.2019, the first instance, namely Constanta Court of Justice gave the following decision: it admits the summons submitted by the complainant Oil Terminal SA, in contradictory with the defendant Master Chem Oil DMCC. It obliges the defendant to pay the claimant the amount of 601,336.89 lei, the equivalent of 154190.20 USD, representing cutter stock oil pruduct storage invoices and delay penalties related to debt. It obliges the defendant to pay the claimant the amount of 20,998.84 lei, representing court expenses. The sentence was appealed by Master Chem Oil DMCC, the file has the first term in Constanta Court of Appeal on 06.11.2019.

For this client, a regulation for the receivable' impairment in an amount of 601,337 lei was constituted.

X. File 8832/212/2018 opened in Constanta Court of Justice, complainant Milea George and defendant Oil Terminal SA. Action in claims, by which the complainant asks for penalties in an amount of 1,000 lei/day of delay, calculated on 25.03.2018, until the date of conclusion the service house sale-purchase contract. By Decision no. 8592/29.08.2018, the court ordered to oblige the defendant Oil Terminal SA to pay, in the

creditor complainant' favour, a penalty of 1,000 lei, settled per delay day, until the peformance of the obligation to do. It obliges the defendant to pay the claimant 620 lei as court expenses. The decision is final.

On 15.10.2018, court orders to add the conclusion part addition no.8592/29.08.2018, obliging the defendant to pay ui=in the creditor complainant' favour, a penalty of 1,000 lei, settled per delay day, running since 25.03.2018 until the execution of obligation to provide in the executory title represented by Civil sentence no.10899/21.10.2014, given by Constanta Court of Justice in civil file no. 34986/212/2013, partly altered by Civil decision no. 840/23.10.2015 given by Constanta Court of Justice in civil file no. 34986/212/2013.

By Civil sentence no.10.008/08.07.2019, given in file no.2807/212/2019, Constanta Court of Justice obliged Oil Terminal SA to pay the creditor Milea George penalties in an amount of 453,000 lei for the period 25.03.2018-08.07.2019, for the unfulfillment of obligation settled by Civil sentence no.10899/21.10.2014, given by Constanta Court of Justice in file no. 34986/212/2013, partly changed and became final by Civil decision no.840/23.10.2015, given by Constanta Court of Justice in file no.34986/212/2013 and the amount of 20 lei, as court expenses.

Civil sentence was appealed by Oil Terminal SA, Constanta Court of Justice settled the first term on 19.11.2019. The company paid on 26.08.2019 the amount of 453,000 lei as penalties according to civil sentence of 10.008/08.07.2019, given in file no.2807/212/2019.

For this file, a provision in an amount of 194,000 lei was constituted, the house sale procedure is going on.

XI. File no. 8831/212/2018 opened in Constanta Court of Justice, complainant Dudau Vasile and defendant Oil Terminal

Action in claims by which it asks for penalties in a quantum of 1,000 lei/delay day, applied on 25.03.2018, and until the date of conclusion the service house sale-purchase contract.

By Decision no. 9107/19.09.2018, the court ordered to oblige the defendant to pay the complainant some penalties in a quantum of 1,000 lei per delay day, since 25.03.2018 until the effective execution of the obligation settled in the executory title represented by Civil decision no. 394/16.06.2015, given by Constanta Court of Justice in civil file no.34987/212/2013, regarding the service house. It obliges the defendant to pay the complainant the court expenses in a quantum of 620 lei.

By civil sentence no.15203/ 23.10.2019 given by Constanta Court of Justice in file no. 1424/212/2019, the court obliged Oil Terminal SA to pay the creditor Dudau Vasile the amount of 578,000 lei as penalties calculated for the period 25.03.2018-23.10.2019 for the unfulfillment of the obligation to do settled by the Civil decision no.394/16.06.2015 given by Constanta Court of Justice in file no. 34987/212/2013. It obliges the defendant to pay the amount of 20 lei as court expenses. The decision is final and executory, being disputed.

The company paid on 25.10.2019 the amount of 578,000 lei as penalties according to civil sentence of 23.10.2019.

For this file, a provision in an amount of 647,000 lei was constituted, the house sale procedure is going on.

XII. File 7525/212/2019 opened in Constanta Court of Justice, complainant Olaru Laurentiu and defendant Oil Terminal SA.

Action in claims, by which the complainant asks for penalties in an amount of 1,000 lei/delay day, calculated on 01.06.2018 until the until the service flat' sale-purchase contract conclusion date.

By Decision no. 11376/08.08.2019, the court orders to oblige the defendant to pay, in the creditor complainant' favour, a penalty of 1,000 lei, settled per delay day, since 01.06.2018 and until the execution of obligation to mention in the excutory title represented by Civil sentence no.10900/21.10.2014, given by Constanta Court of Justice in civil file no.34991/212/2013, final by Civil decision no.781/20.10.2015, given by Constanta Court of Justice in civil file no.34991/212/2013. It obliges the defendant to pay the complainant 670 lei, as court expenses. The decision is final.

For this file, a provision in an amount of 579,000 lei was constituted and the flat' sale is going on.

XIII. File 1974/118/2019, pending on Constanta Court of Justice, creditor Oil Terminal SA and the debtor Master Chem OIL DMCC.

Action in claims, by which Oil Terminal SA asks the court to oblige the defendant Master Chem Oil DMCC to pay for cutter stock' storage in an amount of 359,810.45 lei (87,742.89 USD) for the period September 2018-February 2019.

In this file, claims increase requestes were deposited, for a total debt of 847,891.88 lei (202,499.07 USD)

The file has the first term in Constanta Court of Justice settled for 04.12.2019. Until the first court term, Oil Terminal will update the debt value to be recovered by the monthly storage invoices' value.

For this client, a regulation for the receivable' impairment in an amount of 879,355 lei was constituted.
