Important events to report: Favourable decision issued by the Bucharest Court of Appeals related to One Floreasca Towers development

The management of One United Properties S.A. (hereinafter referred to as the "Company") hereby informs the market that on May 26th, 2026, the Bucharest Appeal Court made public its decision rejecting the second appeals filed by the Bucharest Municipality and the General Mayor of Bucharest in case file 18079/3/2023. These parties had challenged the decision issued in first court in case file 18079/3/2023 on February 7th, 2024 where the Bucharest Tribunal had rejected both the annulment and suspension claims concerning the building permit pertaining to the "One Floreasca Towers" development.

This decision issued by the Bucharest Court of Appeals is final and binding.
