The Romanian capital market has fully recovered from the decline caused by the war in Ukraine as the BET-TR index increases by almost 1% in the first 6 months

- The outbreak of the war in Ukraine at the end of February caused the Romanian capital market to decrease by 3.6% in the second month of the year when looking at the BET-TR index, which also includes dividends. Four months later, the capital market returned an increase of 0.8%, also for the BET-TR index.
- The Romanian capital market fully recovered from the declines caused by the war in Ukraine by the end of the first half of this year, but the other external risks are still present and can significantly influence the activity in the capital markets.
- By comparison, the total return variants of US's S&P500 index or of Europe's STOXX600 index went down by 20%, respectively 15% at the end of the first 6 months.

- *We expect volatility to continue to be present in the second half of the year, but the amplitude and frequency of these adjustments cannot be predicted.*

The volatility that engulfed the international capital markets at the beginning of the year continued to make its presence felt throughout the first semester, at the end of which most stock indices were in negative territory. The anxiety of international investors was accentuated in February and reached new heights following the outbreak of the armed conflict between Russia and Ukraine. At the end of February, the Romanian capital market went down by 3.61% in the case of BET and BET-TR, an index that also includes dividends. This decline was in line with the evolution of the indices in the developed markets: -3.14% for US's S&P500 and -3.36% for Europe's STOXX600 indices. Subsequently, until the end of the first half, the Romanian capital market decoupled from this downward trend. At the end of June, the Romanian capital market returned an increase of 0.8%, through the lens of the BET-TR index, and thus fully recovered the decreases caused by the war in Ukraine. By comparison, the total return variants of the S&P500 or STOXX600 indices decreased by 20%, respectively 14.6% at the end of the first 6 months. The international indices of total return type such as FTSE Emerging Markets or MSCI Frontier Markets - indices in which Romania is also included - were in negative territory with -14.8%, respectively -20.5%. The evolution of these indices can be seen in Graphic 1.

Other external risks related to the evolution of the coronavirus pandemic, rising inflation, rising interest rates, rising energy prices, supply chain dysfunctions as well as fears of a possible recession in developed markets are still factors that can significantly influence the activity in capital markets. In such a context, the capitalization of Romanian companies remained at the level recorded at the end of last year: RON 141 billion or EUR 28.5 billion.

„Romania has proven to be a pole of stability in the region. This fact is strengthened by the continuation of the upward trend of the listings of Romanian companies on the stock exchange and by the extension of Romania’s representation on the radar of international investors. The results for the first 6 months show us that the investors who trusted Romania had an upside potential. Opportunities and threats are always present in capital markets, which are currently going through a complicated context because there are multiple factors that are difficult to quantify in the short term. The fact that Romania has positioned itself better compared to other indices or other markets is not a guarantee for the future, but it is an image that captures the evolution of the market at a given time and this image is relevant for investors when deciding where to allocate capital”, said Radu Hanga, President of the Bucharest Stock Exchange.

„The first half of the year was intense for the international capital markets, not only for Romania. Strong episodes of volatility contrasted with sessions where the investment activity was reduced. We could also observe these phenomena on the Bucharest Stock Exchange, but we found that the Romanian capital market reacted maturely, and investors identified here opportunities to preserve or increase capital, which made Romania an attractive investment destination. We expect volatility to continue to be present in the second half of the year. One of the characteristics of the capital market is that it is an efficient market, and supply and demand correct the discrepancies that occur, but the amplitude and frequency of these adjustments cannot be predicted. That is why for Romanians who want to invest their savings in shares and bonds listed on the local stock exchange, investing recurrently, diversifying among asset classes, and adopting a long-term investment perspective are key elements that can produce very good results with a minimum of effort”, said Adrian Tănase, CEO of the Bucharest Stock Exchange.

The investment activity from BVB was heightened in the first quarter only to slow down in April and May when it comes to the daily average trading values. For example, in the equity segment for the shares listed on the BVB’s Regulated Market, January posted the highest average daily trading value, of over RON 100 million, while April saw the lowest average daily value, of RON 27 million. Overall, during the first half of the year, the investment activity was robust on BVB, with an average daily value of over RON 60 million for the equity segment. Taking into account all types of financial instruments, the same indicator shows a level of RON 109 million (EUR 22 million), increasing by 60% compared to the first 6 months of the previous year. The total trading value of all types of financial instruments exceeded RON 13.5 billion (EUR 2.73 billion) in the first half of this year. The investors operating on BVB became much more active in January-June this year and introduced 56.8% more sell-buy orders than in the same period last year. Thus, at the level of the first six months of the year, over 824,000 transactions were performed.

Romania has become increasingly visible internationally and has been present, since June 20th, with 12 companies in the Russell FTSE index dedicated to emerging markets. The 12 companies are: Banca Transilvania, Nuclearelectrica, OMV Petrom, TeraPlast, One United Properties, MedLife, Transport Trade Services, Purcari Wineries, Conpet, IMPACT Developer & Contractor, Sphera Franchise Group, and Aquila.

News to investors

- ❖ Sipex Company, the company operating in the distribution of construction materials and finishes field, debuted on June 3rd on the AeRO market, the equity segment of the Multilateral Trading System of the Bucharest Stock Exchange (BVB). The company's shares will be traded under the SPX stock ticker. The company listing was preceded by the private placement through which it attracted RON 10.6 mn from the capital market investors. The anticipated market capitalization of the company is RON 170.6 mn. Further details are available [here](#).
- ❖ Banca Comercială Română (BCR), one of the most important financial groups in Romania, lists on June 22nd a new green bonds issue, worth RON 702mn, under the stock ticker BCR27A. It is the second issue of green bonds listed by BCR at the Bucharest Stock Exchange (BVB), after the first one in October last year, worth RON 500mn. The non-preferential senior green bonds to be listed have a maturity of 5 years and an annual fixed rate of 9.079%. The new issue of green bonds is in line with the bank's efforts to align with the ESG (Environmental, Social and Governance) criteria. The bonds received a long-term BBB+ rating from the agency rating Fitch. Further details are available at this [link](#).
- ❖ Crama La Salina, wine producer from Turda, with a vineyard extending over 42 hectares located on the Durgău Hills, in an area with a millennial tradition in viticulture, listed on June 23, 2022, its first bond issue on the Multilateral Trading System (MTS) of the Bucharest Stock Exchange. The bonds worth EUR 2mn are traded under the ISSA26E stock ticker. Further details are available at this [link](#).
- ❖ Raiffeisen Bank, key player in the Romanian banking sector, lists on June 24th a new issue of green bonds at the Bucharest Stock Exchange (BVB) worth RON 525mn. The bonds traded under the RBRO27 stock ticker are the third green bond offer that Raiffeisen Bank lists at BVB, after the 2 issues from 2021, the total value of the 3 offers listed exceeding RON 2bn. The non-preferential senior green bonds which entered trading on June 24th have a maturity of 5 years and an annual fixed interest rate of 8.927% per year. Raiffeisen Bank issued and sold to 13 bondholders and legal entities a number of 1,000 corporate bonds with a nominal value of RON 525,000. Further details are available at this [link](#).

- ❖ The Ministry of Finance (MF) listed on June 27th four new issues of FIDELIS government bonds totaling over RON 1.44 bn. The four issues are traded under the stock symbols R2306A, R2506A, R2306AE, R2406AE. The debut of FIDELIS government bonds at the Bucharest Stock Exchange (BVB) comes after the successful conclusion of the public offer held between June 6 and June 21. In total, in the last two years, MF has attracted from the retail investors over RON 12.4 billion (EUR 2.5 billion). The income obtained through the investment in FIDELIS government bonds, both from interest and from capital gains, is non-taxable. Further details are available at this [link](#).
